Dr. Jacqui Kearns is Project Director at the University of Kentucky's University Center for Excellence in Developmental Disabilities, the UK Human Development Institute. She serves as the Primary Investigator for TAALC, a project to support students with disabilities to build competence in communication. Dr. Kearns is a certified educator and has many years of experience with students who have multiple disabilities. She is recognized as a national authority on assessment and research with students in the Alternate Assessment, and she provides professional development at a state and national level.

- Participants will be able to describe the communication characteristics of students with the most significant disabilities.
- Participants will be able to identify communication output and idiosyncratic communication behaviors in students with significant disabilities.
