Day 1: Developing the IEP: This session will provide direct instruction in using the Guidance Document as a guide for creating a meaningful, data-driven Individual Education Plan that is compliant and directly aligned with a student’s individual needs, strengths, learning style, and goals. Each participant will leave the session with a toolkit of resources for writing the IEP.

Day 2: Implementing the IEP: This session will focus on the implementation of the IEP and student outcomes for new teachers. The day will be structured with mini-sessions on annual goals, data collection/progress monitoring, specially designed instruction, supplementary aids and services, assessment accommodations, least restrictive environment, and transition. Educators will have the opportunity to learn instructional strategies and create resources that they can incorporate in the classroom the very next day.
