Most bookkeepers/secretaries are familiar with the guidelines in *Accounting Procedures for Kentucky School Activity Funds* (commonly known as the Red Book); however, procedures are not always followed and some are new in positions or have not received formal training of this nature. Since the principal has the overall responsibility of the School’s Activity Fund, this training will provide the required training needed to assist in the management of those funds and activities.
